INDEPENDENT FEE ANALYSIS FAA REQUIRED

Required by Federal Aviation Administration FAA — 49 CFR 18.36. An airport sponsor that receives FAA grants must perform an Independent Fee Analysis (IFA) on every Architectural and/or Engineering contract. Airports have an obligation to obtain a fair and reasonable fee in all cases, and the FAA retains the right to disallow negotiated fees that are determined to be unreasonable.

While some airports may have in-house expertise, others need to seek assistance from professionals that have an understanding of these services and the FAA's requirements.
